Rob advised they are doing really well and the roll has increased. The Ministry has corresponded with Rob about this and Rob advised that now there is zoning, this has increased the roll.

The budgeted surplus for last year was \$48,400 and actual was \$238,000 (a lot of this has been set aside for rebuild).

Rob has a quote for a canopy/awning over the hall of around \$80K. Heather may be able to look into a funding application for this. Also shade over both play grounds along with some astroturf.

Property:

The hall is close to being completed on the inside. New spouting is being put up. The kitchen was being finished and should now be completed. Rob to check. There has been some additional funding from the Ministry due to COVID delays.

The rebuild time line is off. The back staff carpark was ready, but due to defects there are a number of things to be remedied before sign off. Once it has been signed off, staff can move their vehicles there and the front carpark will be demolished. This will cause issues and Rob has asked for a safety plan. Access from the road to the admin block will be needed. Rob also feels that for the carpark should not be done in two halves as it makes it susceptible to leaks and he doesn't feel doing it piecemeal is a good idea. They have agreed and Rob is meeting tomorrow to ensure this doesn't happen until everything is moved from the garage and the entire carpark can be done once the garage has been demolished.

The pool solar system has been completed. The pool needs emptying for the surface to be completed. This will be done once more of the rebuild is completed. The resurface may need to be fund raised also.

The rebuild has slowed as the joinery company providing the windows was damaged during the floods and cyclone. Others are being sourced.

The severe noise was due to an error made and concrete had to be grinded out. Rob has asked them to complete this outside of school hours.

Rob has discussed 5YA funding with the Ministry and pointed out the 10 year plan was primarily for the funding for the hall upgrade. Also there was to be a complete rebuild, but it has only been a part rebuild. Rob also pointed out funding will be needed to improve the admin block and the remaining classrooms not included in the rebuild as due to the roll, Stage 2 will not occur.

Ministry feels the rebuild probably won't be completed to move in until next year.

Rob has been appointed to the Truancy Services Governance Group.

Rob will at the National Principles meeting on Friday in Wellington.

Rob added that it is the first time in his career he has known the teachers to strike. The strike is also about support around the students.

It was moved to proceed and renew the Licence to Occupy with the Uni Services for the reading recovery training centre.
